~~RESPONDENT'S PROPOSED~~ ORDER  
GRANTING TEMPORARY INJUNCTION

The Parties in this case filed an agreed Motion for Continuance wherein they agreed to a hearing at 10:00 on October 25, 2022. At 10:00am, Counsel for the Church of God in Christ and the Representative of the Church of God in Christ was present. Respondent and Counsel for the Respondent were not present in the courtroom.

At approximately 10:15am, the matter was called for hearing. The clerk of the Court called Counsel for Respondent to inquire as to whether they would be attending the hearing. The clerk was advised that they would not be attending because defense counsel believed the matter was set for October 31, 2022. The Court noted on the record that no notice of hearing was filed with such date. The matter proceeded to trial.

After hearing testimony and reviewing evidence and argument of counsel, the Court determined that The Church of God in Christ has presented sufficient evidence to show that it is entitled to the requested injunctive relief.

It is therefore ORDERED that Rufus Kyles, Jr. and those operating as his representative, at his direction and or in concert with him are Temporarily Enjoined from:

1. Coming within 500 feet of Evangelist Temple Church of God in Christ, 11603 Martin Luther King Jr. Blvd, Houston, Texas 77048.
2. Proclaiming, or in any way representing or holding out Rufus Kyles, Jr. as a Bishop.
3. Proclaiming, or in any way representing or holding out Rufus Kyles, Jr. as the Pastor of Evangelist Temple Church of God in Christ 11603 Martin Luther King Jr. Blvd. Houston, Texas 77048.

Trial is set for April 10, 2023 on the two week docket. The Court will generate a Docket Control Order.
